TERMS & CONDITIONS

1. A *non-refundable* deposit of 50% is required to hold equipment for date of event. Please send a check and a filled out copy of this document to the address listed below. Final payment is due the day of delivery. We accept cash and/or check. Please make checks out to Premier Tent Rental, LLC
2. Rentals include equipment, delivery, setup and teardown. An additional delivery fee may be assessed for deliveries outside a fifteen mile radius, at \$25 for each additional 25 miles. There will be a \$30 delivery fee for chair-only rentals. Lessee of lighting must provide their own source of electric power and extension cords.
3. For *specific* setup/delivery times, please call *at least* three days in advance. Otherwise, we will get there as close to the assigned time as possible.
4. In the event of harsh weather or acts of god, (Severe thunderstorms, tornados, high winds, etc.), please evacuate the tent & *do not* mess with the tent. If anything happens, please call us & we will take care of it. We reserve the right to delay setup (on day before event) or take the tent down to prevent equipment, persons, and property from any possible harm or damage. If the harsh weather improves overnight (before event), the tent will be setup the morning of the event. We also reserve the right to cancel any order in the event that harsh weather doesn't allow for setup, or will cause harm to any rented equipment, as well as persons or property. In this rare event, your deposit will be refunded in full.
5. The lessee *is* responsible for *all* equipment from the point of delivery until pick-up. The lessee will also take on *full responsibility* & *will* be held liable for any damages that occur to any/all equipment. Lessees will be charged for damaged, broken, lost, or stolen equipment at the replacement expense.
6. All rented equipment *must* be free of materials such as food, ribbon, tape, balloons, tablecloths, etc. prior to pickup, or a cleaning charge *will* be assessed. Chairs *must* also be folded and stacked on top of tables *prior* to pickup.
7. Damage to lawn or property *may* result due to vehicle and trailer weight, as well as stakes and other necessary tools to keep tent stabilized. Please have sprinkler systems labeled, and animal feces cleaned up prior to our arrival.
8. By printing, signing, and dating the line below, you adhere to the following terms and conditions as described above and indemnify, defend and hold Premier Tent Rental, LLC, its owners and employees harmless from and against any and all liability and costs incurred by the indemnified parties in connection with any claim arising out of any breach by you of this agreement or the harm/damage to persons and/or property caused by any/all equipment.
